IMPORTANT APPLICATION INFORMATION

- **ELIGIBILITY.** Applicants must be either 18 years of age OR an undergraduate student. On-campus housing is for enrolled Summer Session students only. You can be housed only if you have a valid UMass Amherst ID Card (UCard). No student can be assigned or checked-in until the housing fee has been PAID IN FULL.
- **FELONY CONVICTION.** All applicants must answer the question regarding a felony conviction in the United States. Your application will not be processed without an answer.
- **ACCOMMODATIONS.** There are two types of accommodations: private rooms and shared rooms. Assignments will be made according to which accommodation has been requested and PAID IN FULL.
- **PAYMENT** must be made in U.S. Currency in the form of a bank check, postal money order, or cashier's check. **NO PERSONAL CHECKS CAN BE ACCEPTED.** No student can be housed until the housing fee has been paid in full, IN ADVANCE. These fees are refundable only in the event the summer session class is cancelled.
- **TELEPHONE** and **ETHERNET** service are mandatory requirements for all Summer Session residents. The Telephone and Ethernet Service Activation Form is included as part of this Housing Application bundle. **Return the form with payment to the address on the Service Activation Form.** Students must supply their own telephones.
